## **Action/Discussion Items:**

- Council reviewed the email exchange between E. Galamba and Matt from the East Pikeland Zoning Board regarding putting an electronic sign along Route 724. Was not positive feedback from Matt. Current zoning for sign size is 15 square feet. Our current sign is 25 square feet which we are grandfathered into. Also, only allowed one sign so our current sign would have to be removed. - A discussion was held on the flooring replacement in the Office Area. A quote was received from Leaf Flooring Covering in the amount of \$7,000 (actual was \$7,350 but they gave us a friends and family discount) for removal of carpet and installing vinyl in pastor's office, pastor's bathroom, middle section, and Erin's office. They want a downpayment of half the amount. Quote needs to be signed in 30 days. The flooring will be like what is in the Fellowship Hall and hallways. If tiles start to pop up when the carpeting is being removed, Leaf Flooring will stop work and Zion will need to find someone to remove the tiles. S. Moore will work with D. Bauman to get a 2<sup>nd</sup> quote. This is going back on Properties plate for another month.
- E. Galamba is keeping a spreadsheet of what the plan for the renovation of the office is and what decisions are being made. We need to make sure we keep her informed as to decisions being made.
